



## WAIVER AND RELEASE AGREEMENT (Youth Programs) Bonnyville and District Centennial Centre

Please read carefully before signing. The Bonnyville and District Centennial Centre strives to provide awareness of possible risks associated with the use of the facility. It should be understood that there are risks and dangers inherent with participation in any physical activity.

### The undersigned agrees as follows:

1. I **acknowledge** that the Bonnyville and District Centennial Centre programs and activities require a certain level of physical, mental, and emotional health. I **further understand and acknowledge** that the probability of an injury occurring depends in part on my child, as well as on the awareness, care, and skills with which my child conducts his or herself.
2. I **acknowledge** that there are risks and dangers inherent with participation in a physical activity. my child shall participate in physical programs and utilize equipment and services at my child's own risk. these risks and dangers include but are not limited to: the possibility of embarrassment, physical injury, concussion, soft tissue damage, infectious diseases, even including the possible risk of severe or fatal injury.
3. I **acknowledge** that my child's participation in any Bonnyville and District Centennial Centre's program or activity is purely voluntary and such participation is done at my child's own risk and they are free to withdraw at any time. I and my child shall release and discharge the Bonnyville and District Centennial Centre, its agents and employees from any and all claims, demands or actions, based on negligence of the Bonnyville and District Centennial Centre.
4. I **acknowledge** that it is my personal responsibility to ascertain where my child has any health conditions which make it inadvisable to participate in any Bonnyville and District Centennial Centre's program or activity.
5. I **acknowledge** that the Bonnyville and District Centennial Centre is not responsible for any lost, damaged or stolen property.
6. I **acknowledge** that I am the parent or legal guardian of the child or children listed below and have the legal right to sign this waiver.
